Earl Doderer of San Antonio passed away on Wednesday, February 16, 2011. He was 76.

Earl was born June 11, 1934, in Monticello, NY.

After graduating from Union College, he started his 21-year career in the Air Force, during which he earned two Master's Degrees and his PhD from Princeton University, fought in Vietnam and achieved the rank of Colonel. He earned the Distinguished Flying Cross for a low-fuel late-night mission over Laos where he kept a village illuminated with flares and saved them from enemy attack. After retiring in 1977 and settling in San Antonio, Earl started his second career of 21 years, teaching at Trinity University. During his time there, he touched many students' lives, both educationally and personally, and earned the position of Professor and Engineering Department

Former Roscoe vet is back home

Welcome home to Thad Bull, formerly of Roscoe, who just returned home from Afghanistan (Operation Enduring Freedom). Mr. Bull serves with the NY Army National Guard's 827th Engineer Company, which has a detachment at the Armory in Walton. Once again, welcome home and thank you for your service to our country. Congrats also to 1st Lt. David Provencher of Ellenville, who was awarded the Silver Star for bravery and saving three soldiers in Afghanistan.

More problems at Arlington National Cemetery, the Army has opened up an investigation into the recent discovery of eight urns containing cremated remains found in a grave marked "unknown." According to cemetery spokeswomen Kaitlin Horst, officials learned of the problem in October and a forensic anthropologist helped identify three sets of the remains. Criminal Investigation Command special Agents are still attempting to identify the others and notify the families.

This most recent probe into the cemetery comes less than a year after a scathing report by the Army's inspector general, Lt. Gen. Steven Whitcomb, revealed dysfunctional management, a lack of established policies, an unhealthy workplace climate and gaps in record keeping and accountability that led to at least 211 discrepancies between burial maps and grave sites. Christopher Grey, a spokesman for the army Criminal Investigation Command, has acknowledges that previous problems might have been accidental, but said they are questioning

whether this most recent case was truly a mistake. "When there's eight set of human remains in one grave, it's most likely not a mistake, so we have to look into whether there is any criminality involved," Grey told USA today.

Under a new program, the Dept. of Veterans Affairs and the Veterans Health Administration will begin an extensive, 12-week survey of former service members. The results of which will help the VA shape its future policies, programs and budgets. In all, about 42,000 enrolled in the VA system will be asked to participate in a 15to 30-minute telephone interview. It is critically important for veterans to participate in this survey, so that the VA can address our needs and concerns along with theirs. As veterans, we need to take advantage of opportunities to speak openly about ways that VA can make their healthcare services even better and create new services as well. Questions will be of a wide variety and we, as veterans, need to be patient and to answer their queries to the best of our knowledge.

If you are contacted by the VA about this survey please be patient and courteous, al lowing them the time they need to complete this survey. If you are caught at a bad time, you will have a chance to call back when it is more convenient. Please remember it is for our benefit and your input is most important. If you have a question about this program contact your local VA Healthcare Clinic. It may seem like an inconvenience now but it will help shape the future of our veterans' health care.
